Heard Mr. Abhishek Manu Singhvi, Mr. Basava P.Patil, Mr. M.G. Ramachandran, Mr. Mohinder Singh, Mr. Sanjay Sen, learned senior counsel and Mr. Vishrov Mukherjee, learned counsel appearing on behalf of the Appellants and Mr. Parag Tripathi, Mr. Nikhil Nayyar, Mr. Buddy A Ranganadhan, learned senior counsel, appearing on behalf of the respondents.

We have heard Mr. Parag Tripathi, learned senior counsel appearing on behalf of MSEDCL.

During the hearing, it has been brought to our notice by learned counsel for the Appellants that disconnection notices have been issued to few of the Appellants on account of non-payment of bills raised in pursuance of the impugned order. Upon taking note of this fact and also considering that we are in the midst of hearing of these appeals, we find it in the interests of justice and equity to stay the disconnection notices as well as the bills, in so far as these reflect the amounts calculated in terms of the new banking of power mechanism, promulgated by the Commission in the impugned order.

Accordingly, we direct so. This interim order shall remain in force till the judgment is pronounced in these appeals by this tribunal. This shall also be subject to an undertaking to be submitted by the Appellants before this Tribunal to the effect that in case the appeals are decided against them, they shall pay entire amount stayed by way of this in terms of the interim order within one month of the judgement, provided, there is no stay from Supreme Court during that period. Meanwhile, the Appellants shall continue paying the banking charges as per the previous power banking regime, which was in force prior to passing of the impugned order.
